Assignment of ExCPT Pharmacy Technician Exam Agreement  
and the  
Amendment to ExCPT Pharmacy Technician Exam Agreement

This Assignment of ExCPT Pharmacy Technician Exam Agreement and its Amendment to the ExCPT Pharmacy Technician Exam Agreement ("Assignment Agreement") is effective as of January 15, 2007, and is entered into by Midwest Pharmaceutical Consultants ("Assignor") and Medical Certification Institute, Inc. ("Assignee"). Assignor and Assignee are sometimes collectively called "parties".

WHEREAS, effective on January 1, 2006, the National Association of Chain Drug Stores, Inc. ("NACDS"), and the National Community Pharmacists Association ("NCPA") (hereinafter collectively called "Grantors") entered into the ExCPT Pharmacy Technician Exam Agreement and Addendum to ExCPT Pharmacy Technician Agreement ("ExCPT Addendum"). The Agreement and Addendum are collectively referred to herein as "Agreement"; and

WHEREAS, effective on January 1, 2007, the Grantors and Assignor entered into an agreement clarifying the Agreement, titled "Amendment to ExCPT Pharmacy Technician Exam Agreement ("Amendment"); and

WHEREAS, Assignor wishes to transfer the Agreement and the Amendment (collectively "Agreements of Grantors") to Assignee.

NOW, THEREFORE, Parties in consideration of the premises above, the mutual covenants and conditions set forth in this Assignment Agreement, and good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties hereto agrees as follows:

1. Assignment. Assignor hereby assigns to Assignee, and Assignee hereby accepts and assumes, all of Assignors rights and obligations under the Agreements of Grantors, including but not limited to any and all intellectual property rights, trade secrets, copyrights and/ or trademarks and all improvements and derivatives related to the "Intellectual Property", as such term is defined in Paragraph 2 of the Amendment. Without limiting the foregoing, this assignment includes all ongoing maintenance obligations and any known or unknown claims of any party that now exist or which may later arise in connection with Assignor's past performance or Assignee's future performance of the Agreements of Grantors.

2. Complete Agreement. This is the complete and final expression of the Assignor's and Assignee's agreement and can be modified only in a writing signed by all the parties.

The undersigned representatives of each party represent and warrant that they are each duly authorized to sign this agreement on behalf of their principals identified below, and do hereby sign on behalf of same.
