ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF  
SYNOVIS SURGICAL SALES, INC.

- 1. The name of the corporation is Synovis Surgical Sales, Inc.
- 2. The following is the full text of the amendment to the Articles of Incorporation of Synovis Surgical Sales, Inc.:
