## CORRECTIVE ASSIGNMENT

This **CORRECTIVE ASSIGNMENT** is effective as of December 24, 2002, by and between DESA International LLC, a limited liability company then organized under the laws of the State of Delaware ("Assignor"), and DESA IP, LLC, a limited liability company organized under the laws of the State of Florida (Assignee").

WHEREAS, Assignor previously transferred to Assignee certain trademarks pursuant to that document entitled "Trademark Assignment" executed and delivered May 14, 2003, but effective as of December 24, 2002 (hereinafter referred to as "2002 Trademark Assignment"), a copy of which is appended hereto as Exhibit A and the terms of which are incorporated herein by reference;

WHEREAS, on December 29, 2008, DHP HOLDINGS II CORPORATION, the parent company of Assignee DESA IP, LLC, filed for protection under the provisions of Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the District of Delaware (Case No: 08-13422 (MFW));

WHEREAS, the undersigned, Craig S. Dean, Principal with AEG Partners, 200 West Madison Street, Suite 2410, Chicago, Illinois 60606, was subsequently appointed by the Bankruptcy Court and continues to serve as Chief Reorganization Officer of DHP HOLDINGS II CORPORATION and its related entities, which includes DESA IP, LLC;

WHEREAS, as part of the undersigned's dealings with the liquidation of DHP HOLDINGS II CORPORATION and its related entities, including DESA IP, LLC, the undersigned is familiar with the facts and circumstances surrounding the ownership and transfer of Assignee's intellectual properties, including the trademarks set forth in the 2002 Trademark Assignment;

WHEREAS, pursuant to the 2002 Trademark Assignment, Assignor assigned to Assignee all of Assignor's right, title and interest in and to the trademark POWER TRIGGER, together with the goodwill of the business associated therewith, along with the corresponding application to register the mark with the United States Patent & Trademark Office ("USPTO"), that being Application Ser. No. 76/486,662, filed pursuant to Section 1(b) of the Trademark Act;

WHEREAS, the 2002 Trademark Assignment inadvertently omitted the language reflected in Section 10 of the Trademark Act to confirm that the trademark POWER TRIGGER and Application Ser. No. 76/486,662 were being assigned to a successor to the business of the Assignor to which that mark pertained. This inadvertent omission in the 2002 Trademark Assignment was only just brought to my attention and the omission of this language was one which, I verily believe, was unintentional.

NOW THEREFORE, the undersigned, on behalf of DESA IP, LLC now submits this Corrective Assignment to clarify the 2002 Trademark Assignment to the extent necessary to formally recognize that, pursuant to Section 10 of the Trademark Act, DESA IP, LLC was at the time of the assignment effective December 24, 2002, a successor to that part of the business of the Assignor DESA International LLC to which the mark POWER TRIGGER pertained.
