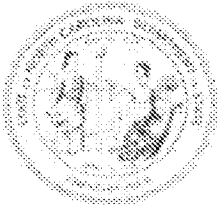

 AMENDED AND RESTATED ARTICLES OF INCORPORATION

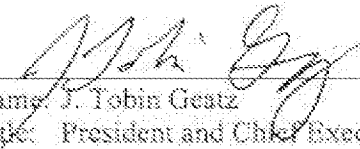
