## PARTIAL RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS PARTIAL RELEASE AND REASSIGNMENT OF TRADEMARKS dated August 29, 2009 by HARRIS N.A., as agent as hereinafter described;

### WITNESSETH:

WHEREAS, HARRIS N.A., as agent (the "Secured Party") with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 and Skylark Meats, LLC, a Delaware limited liability company with its mailing address at 4430 S. 110th Street, Omaha, Nebraska 68137 (the "Debtor") are parties to a certain Trademark Collateral Agreement dated August 29, 2005 which was recorded in the United States Patent and Trademark Office on September 2, 2005 at Reel 3185, Frame 0598, pursuant to which the Debtor granted a security interest in and collateral assignment of, among other property, those certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "Trademarks"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to:


(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.

THIS IS A PARTIAL RELEASE ONLY; EXCEPT AS TO THE TRADEMARKS SPECIFICALLY RELEASED HEREBY, THE SECURITY INTEREST PERFECTED BY THE AFOREMENTIONED TRADEMARK COLLATERAL AGREEMENT IN EACH AND EVERY OTHER TRADEMARK CONTINUES IN FULL FORCE AND EFFECT TO THE SAME EXTENT AS IF THIS PARTIAL RELEASE AND REASSIGNMENT OF TRADEMARKS HAD NOT BEEN RECORDED.
