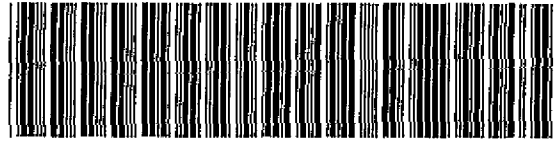

The undersigned Directors of FAUX EFFECTS INC., hereby amend the Articles of Incorporation for said corporation, as follows:

AMENDMENT #1

"The name of the corporation shall be: FAUX EFFECTS INTERNATIONAL, INC."
