**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated August 29, 2009 by HARRIS N.A., as agent as hereinafter described;

**WITNESSETH:**

WHEREAS, HARRIS N.A., as agent (the "*Secured Party*") with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 and Knauss Snack Food Company, LLC, a Delaware limited liability company with its mailing address at 200 Knauss Drive, Martinsville, Virginia 24112 (the "*Debtor*") are parties to a certain Trademark Collateral Agreement dated August 29, 2005 which was recorded in the United States Patent and Trademark Office on September 2, 2005 at Reel 3185, Frame 0605, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademarks*"); and


