THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated August 31, 2009 by BANK OF MONTREAL and HARRIS N.A., as successor by merger with Harris Trust and Savings Bank;

**W I T N E S S E T H:**

WHEREAS, Bank of Montreal with a mailing address at 11th Floor, First Canadian Place, Toronto, Ontario M5X 1A1 Canada and Harris N.A., as successor by merger with Harris Trust and Savings Bank with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (Bank of Montreal and Harris N.A. are collectively referred to herein as the "*Holder*s") and Pet Valu Canada Inc., a corporation organized under the laws of the Province of Ontario (hereinafter referred to as the "*Corporation*") with its mailing address at 130 Royal Crest Court, Markham, Ontario L3R 0A1 are parties to a certain Collateral Assignment for Security (Trademarks) dated November 10, 2004 which was recorded in the United States Patent and Trademark Office on December 1, 2004 in Reel 002984, Frame 0482 (the "*Agreement*"), pursuant to which the Corporation granted a security interest in and collateral assignment of certain trademarks listed on Schedule 1 attached hereto and certain other property (collectively, the "*Trademarks*"); and

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:






