## TRADEMARK QUITCLAIM AND ASSIGNMENT AGREEMENT

This Agreement is made and entered into as of June 1, 2006, by and between Halcyon Entertainment, Inc. ("Halcyon") and Concord Music Group, Inc. ("Concord").

WHEREAS, Halcyon owns or controls the trademarks and/or service marks in Neon Tonic (Trademark Registration Nos.: 2766625 and 2761483) for the following services: musical sound recordings (collectively, the "Halcyon Trademarks").

WHEREAS, it is Halcyon's intention to quitclaim, assign and transfer to Concord all of Halcyon's right, title, and interest in and to the Halcyon Trademarks.

WHEREAS, Concord desires to acquire the Halcyon Trademarks.

WHEREAS, each party is duly authorized and capable of entering into this Agreement.

In consideration of the covenants set forth herein, Halcyon hereby agrees as follows:

1. In consideration of one dollar (\$1.00), receipt of which is hereby acknowledged, Halcyon hereby quitclaims, assigns and transfers, without limitations, to Concord any and all right, title and interest in and to the Halcyon Trademarks, which are owned or controlled by Halcyon, together with all goodwill associated with the Halcyon Trademarks, including, without limitation, the right to sue and collect damages for infringements of the Halcyon Trademarks and all trademarks renewals, extensions and continuations thereof, whether common law, statutory, or otherwise, and Concord shall have the exclusive right to obtain and register the trademark renewals or analogous protection for the Halcyon Trademarks, for the United States and all countries of the world.

2. Halcyon possesses the full right, power, and authority to grant the rights herein granted, to enter into and to perform this Agreement. Halcyon has not granted and will not grant or attempt to grant to any third party rights of any kind the exercise of which would derogate from or be inconsistent with the rights granted to Concord hereunder. Halcyon owns and controls, without any limitations, restrictions, or encumbrances whatsoever, all rights granted or purported to be granted to Concord hereunder. Halcyon further represents and warrants that there are and will be no liens or encumbrances against the Halcyon Trademarks which is the subject hereof, which would derogate from or be inconsistent with the rights granted to Concord hereunder.
