SUPPLEMENTAL TRADEMARK ASSIGNMENT AGREEMENT

THIS SUPPLEMENTAL TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made and entered into, nunc pro tunc, effective December 1, 2008 (the "Effective Date") by and among CONTECH ENTERPRISES, INC. (formerly known as PHERO TECH INTERNATIONAL, INC.), a British Columbia corporation located at Unit 115-19 Dallas Road, Victoria, British Columbia, Canada V8V 5A6 ("Assignor"), and RADIO SYSTEMS CORPORATION, a Delaware corporation located at 10427 Electric Ave., Knoxville, TN 37932 ("Assignee").

Assignor and Assignee have entered into an Asset Purchase Agreement dated as of December 1, 2008 (the "Purchase Agreement").

Pursuant to the Purchase Agreement, the Assignee wishes to acquire, and Assignor wishes to assign (a) all of Assignors' right, title and interest, worldwide, in and to the trademark "SCAT MAT" (hereinafter, the "Mark"), including, but not limited to, United States Trademark Registration No. 1,992,998 and all United States, Canadian, other national, European Community ("CTM"), international, and all other registrations and applications therefor and renewals and extensions thereof, all common law rights in and to the Mark; and (b), all goodwill associated with the Mark and the business in connection with which the Mark is used.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee all of Assignor's right, title and interest, worldwide, in and to the Mark, including, but not limited to, all United States, Canadian, other national, European Community (CTM), and international trademark applications filed therefor, all other applications filed therefor, all United States, Canadian, other national, European Community (CTM), and international trademark registrations that have issued, or may issue, therefor, all other registrations that have issued, or may issue, therefor, all renewals and extensions of all such registrations that have been, or may be, secured under the applicable laws, rules and regulations of the United States, Canada, the European Community, and all other foreign countries, and all applicable international laws, rules, regulations, treaties and agreements, now or hereafter in effect, all common law rights in and to the Mark, all rights of action for past and future infringement of the Mark, all causes of action and claims for past and future damages with respect to the Mark, all goodwill associated with the Mark, and the goodwill of the business in connection with which the Mark is used, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.

This Assignment shall be effective nunc pro tunc as of the close of business on the Effective Date.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

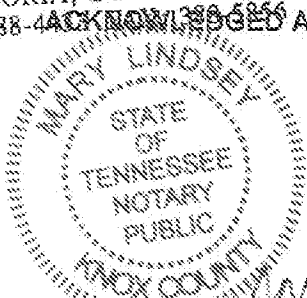
