Confirmatory Grant of a Security Interest in Intellectual Property

THIS CONFIRMS a Grant of a Security Interest in Intellectual Property (the "**Confirmation**") from Springbok Services, Inc., a Delaware corporation with its chief executive offices located at 345 Inverness Drive, Englewood, CO 80122-5890 ("**Borrower**"), to The Bancorp Bank, a Delaware corporation with its chief executive offices located at 1818 Market Street, 28th Floor, Philadelphia, PA 19103 ("**Bank**") pursuant to the terms of a certain Loan and Security Agreement (the "**Loan Agreement**"), dated August 14, 2009. Capitalized terms not otherwise defined herein shall have the meanings assigned in the Loan Agreement.

RECITALS:

Pursuant to the terms of the Loan Agreement, Borrower has granted to Bank a first lien and continuing security interest in all General Intangibles of Borrower, including, without limitation, all of Borrower's right, title, and interest in, to and under all now owned and hereafter acquired Intellectual Property (as defined in the Loan Agreement), including, but not limited to Patents, Patent Applications, Copyrights and Trademarks, together with the goodwill of the business symbolized by Borrower's Trademarks, and Trademark Licenses, and all products and Proceeds thereof, to secure the payment of the Obligations (as defined in the Loan Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Borrower hereby confirms that it has granted to Bank a first lien and continuing security interest in all of Borrower's right, title, and interest in, to, and under the following (all of the following items or types of Property being herein collectively referred to as the "Intellectual Property"), whether presently existing or hereafter created or acquired:

(1) each Trademark, trademark registration ("Trademark Registration") and trademark application ("Trademark Application"), including, without limitation, each Trademark, Trademark Registration and Trademark Application referred to in Schedule 1 annexed hereto, together with the goodwill of the business symbolized thereby; and

(2) each Trademark License, including, without limitation, any Trademark License listed in Schedule 1 annexed hereto; and

(3) all products and proceeds of the foregoing, including, without limitation, any claim by Borrower against third parties for past, present or future (a) infringement, dilution or breach of any Trademark, Trademark Registration, Trademark Application and Trademark License, including, without limitation, any Trademark, Trademark Registration and Trademark License referred to in Schedule 1 annexed hereto, and any Trademark Registration issued pursuant to a Trademark Application referred to in Schedule 1 annexed hereto; or (b) injury to the goodwill associated with any Trademark, Trademark Registration and Trademark Application; and

(4) all Patents and Patent Applications, including, without limitation, any Patent or Patent Application referred to in Schedule 1.

Borrower hereby acknowledges and affirms that the rights and remedies of Bank with respect to the liens and security interests in the Intellectual Property set forth in the Loan Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
