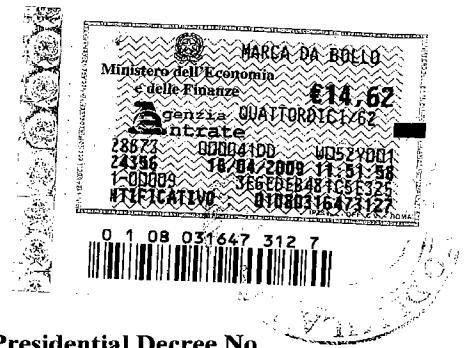

As security for the sums owing on foot of a loan transaction subject to Substitute Tax pursuant to Presidential Decree No. 601 of 29 September 1973, entered into on 12 December 2002 in Milan, the signing of which was authenticated by the notary Giuliano Salvini (file no. 120736 and register no. 16797), registered in Milan as a private deed on 16 November 1998 (the "Loan Agreement"), a deed called "Creation of Pledge of Industrial Property and Rights" was entered into on 12 December 2002 in Milan, the signing of which was authenticated by the Milan notary Luigi Cecala (file no. 14421 and register no. 3658), registered in Milan on 17 December 2002 at no. 7628, series 2, as subsequently extended and confirmed by an agreement called "Extension and Confirmation of Pledge of Industrial Property and Rights", entered into on 14 May 2003 in Milan, the signing of which was authenticated by the Milan notary Luigi Cecala (file no. 15018 and register no. 3859), registered in Milan on 26 May 2003, whereby Safilo – Società Azionaria Fabbrica Italiana Lavorazione Occhiali – S.p.A.
