TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT, effective as of the last date signed below ("Effective Date") is made by and between Klearsen Corporation, a Colorado corporation with a principal place of business at 3125 Sterling Circle Suite 101, Boulder, Colorado 80301, on behalf of itself and its' wholly owned subsidiary, Peaceful Mountain, Inc. ("Assignor") and Walden-Hays, Inc., a New York corporation with an address of P.O. Box 1071, New York, NY 10276 ("Assignee").

WHEREAS, Assignor owns all rights, title and interest in and to the mark SINUS RESCUE, the goodwill of the business symbolized thereby, and the federal trademark registration, Reg. No. 2884131 - SINUS RESCUE.

NOW, THEREFORE, for good and valuable consideration being extant, Assignor hereby assigns to Assignee all of its rights, title and interest in and to the mark SINUS RESCUE, the goodwill of the business symbolized thereby, U.S. trademark registration Reg. No. 2884131, and that portion of Assignor's business to which this mark pertains.

Assignor further assigns to Assignee all right to sue for, to receive and to hold damages and profits accruing from past infringement of the mark SINUS RESCUE.

Assignor warrants that there are no licenses, encumbrances or other agreements, either written, oral or implied, relating to the mark SINUS RESCUE of which Assignee is not aware. If Assignor is in breach of the warranty in this paragraph, Assignor's liability for this breach is capped at \$40,000. Assignor further believes it has good and valid title to the mark to assign to Assignee and warrants that to the best of Assignor's knowledge use and/or registration of the SINUS RESCUE mark does not infringe any third party rights.

This Assignment shall be binding upon Assignor, Assignor's successors and assigns, and upon all others acting by, through, with or under Assignor's direction or control, and all those in privity therewith.
