TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 8, 2009, by GREYSTONE BUSINESS CREDIT II, L.L.C. ("Greystone").

WITNESSETH:

WHEREAS, WAVE2WAVE COMMUNICATIONS, INC. a Delaware corporation, RNK, INC., a Massachusetts corporation (each a "Grantor" and collectively the "Grantors") and Greystone were parties to a trademark security agreement dated as of January 25, 2008 (the "Assignment"), pursuant to which Grantors granted a security interest to Greystone in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantors to Greystone, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on January 31, 2008, at Reel 3708, Frame 0246; and

WHEREAS, Grantors have requested that Greystone release its security interest in the Trademarks and Trademark Rights and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Greystone hereby releases its security interest in all of Grantors' right, title and interest in and to the following (collectively the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(ii) all products and proceeds of the foregoing, including without limitation, any claims by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Greystone hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Greystone, all of Greystone's right, title and interest in and to the Trademarks and the Trademark Rights.
