2. **Approval of Agreement of Merger.** An agreement of merger has been approved and executed by each of the domestic limited liability companies that are to merge.

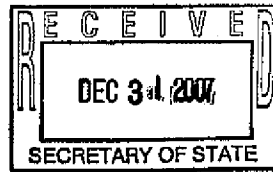
