## TRADEMARK RELEASE

This Trademark Release is made and effective as of the 31<sup>st</sup> day of August, 2009, by ACP-I, L.P., a Delaware limited partnership (the "Secured Party").

WHEREAS, Secured Party and National Archive Publishing Company, a Michigan corporation ("Debtor") are parties to a Trademark Security Agreement, dated as of October 25, 2005 ("Trademark Security Agreement"), pursuant to which Debtor granted a security interest to Secured Party in certain trademarks and related assets as security for certain obligations owing by Debtor to Secured Party under a Credit Agreement, of even date therewith, including without limitation the trademarks and trademark registrations identified in Schedule A hereto (the "Trademarks"), as well as all goodwill associated therewith;

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office on November 18, 2005 at Reel/Frame 3197/0175; and

WHEREAS, pursuant to an Agreement to Assign Trademarks and Domain Names, which was made and became effective on August 31, 2009, the Debtor assigned the Trademarks to XanEdu Publishing, Inc., a Delaware corporation.

WHEREAS, Debtor has requested that Secured Party release its security interest in the Trademarks and Secured Party has agreed to do so.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties:

- A. Secured Party hereby terminates, cancels and releases its security interest in and to all of the following, all rights in and to which shall immediately revert to Debtor:
  - 1. the Trademarks, including without limitation, each of the Trademarks and all of the goodwill of the business related thereto or symbolized thereby; and
  - 2. all products and proceeds of the foregoing, including without limitation, any claim by Debtor against third parties for past, present or future (i) licensing proceeds, or (ii) infringement, dilution or other violation of any of the Trademarks or injury to the goodwill associated with any of the Trademarks.
