## Assignment of Trade Marks

THIS AGREEMENT is made this 29 day of June 2009

**BETWEEN:**

- (1) **DE LA RUE NORTH AMERICA INC.** (a company incorporated in the State of Virginia in the United States of America) of 100 Powers Court, Dulles, VA 20166, United States of America (the “Assignor”).
- (3) **MAESTRO INTERNATIONAL INCORPORATED** (a company incorporated in the State of Delaware in the United States of America) of 2000 Purchase Street, Purchase, New York 10577-2509, United States of America (the “Assignee”).

**WHEREAS:**

- (A) The Assignor is the proprietor of the trade marks set out in Schedule A hereto (the “Trade Marks”)
- (B) Assignor has agreed to assign the Trade Marks to the Assignee on the terms of this agreement.

**IT IS AGREED** as follows:

- 1.1 In consideration of the sum of US\$10 paid by Assignee to Assignor (receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee with full title guarantee the Trade Marks together with the goodwill symbolised by and attaching to the Trade Marks, but not including any goodwill in the business in the goods for which the trade marks are registered, and all rights of action, powers and benefits belonging or accrued to the Trade Marks, including the right to sue for past infringements and passing off.
- 1.2 Assignor shall execute any Trade Mark Registry forms or any other documents to effect the change of ownership and record the same with the relevant Trade Mark Registries. The Assignor agrees that the Assignee or its legal representative is authorised to sign the necessary Trade Mark Registry forms on behalf of the Assignor to effect the recordal of this assignment at the relevant Trade Mark Office.
- 1.3 Assignor shall provide to Assignee without further consideration or remuneration from Assignee any such further reasonable assistance as may be required to assign, transfer, grant, set over and convey effectively to Assignee, Assignor’s entire rights, title and interest in and to the name and mark MAESTRO, the service mark or trademark registrations therefore, together with only the goodwill of the business symbolized by the name and mark MAESTRO, including, but not limited to, execution of any and all other

and further documents reasonably necessary to effectuate the purposes of this Agreement, the assignment therein and to vest unto and perfect in Assignee, all of Assignor's rights, title, interest and use of the name and mark MAESTRO, the service mark or trademark registrations therefore, and only the goodwill of the business symbolized by the name and mark MAESTRO.

1.4 This Assignment shall be governed by and construed in accordance with the laws of England and Wales.




