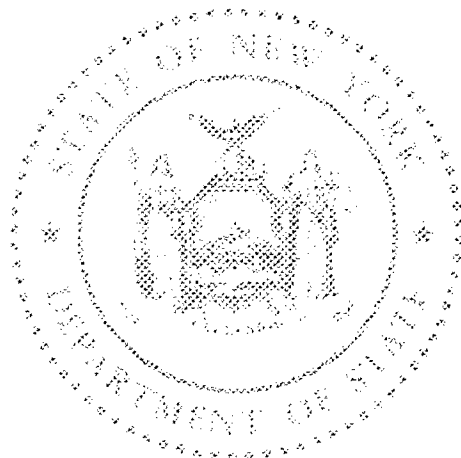

CBS Broadcasting Inc., a New York business corporation, HEREBY CERTIFIES
AS FOLLOWS:

FIRST: The name of the corporation to be merged is CBS Worldwide Inc. ("Worldwide"), a corporation organized and existing under the laws of the State of Delaware. The name under which Worldwide was formed is CBS Worldwide Inc. The name of the surviving corporation is CBS Broadcasting Inc. (the "Corporation"), a business corporation organized and existing under the laws of the State of New York. The name under which the Corporation was formed is United Independent Broadcasters, Incorporated.

SECOND: The designation and number of outstanding shares of each class of Worldwide, all of which are owned by the Corporation, are as follows:

Common Stock, par value \$1.00 per share	100

THIRD: The certificate of incorporation of Worldwide was filed with the Secretary of State of the State of Delaware on December 22, 1997. The Application for Authority to do business as a foreign corporation in the State of New York of Worldwide was filed by the Department of State of the State of New York on January 14, 1998.

FOURTH: The certificate of incorporation of the Corporation was filed by the Department of State of the State of New York on January 27, 1927.


FIFTH: A Plan of Merger was adopted by the Board of Directors of the Corporation by unanimous written consent pursuant to Section 708(b) of the Business Corporation Law of the State of New York on December 27th, 2005.

SIXTH: The merger of the subsidiary corporation into the surviving corporation is permitted by the laws of the jurisdiction of incorporation of the subsidiary corporation and is in compliance therewith.
