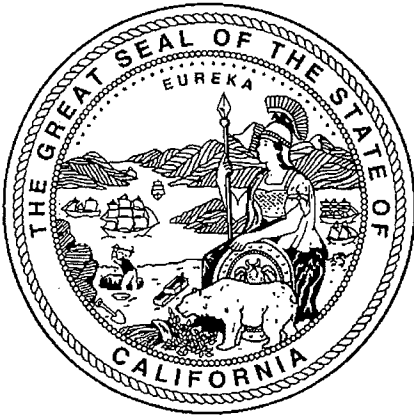

**RESTATED ARTICLES OF INCORPORATION
OF
BISYS COMMERCIAL INSURANCE SERVICES, INC.**

The undersigned certify that:

1. They are the executive vice president and the secretary, respectively, of BISYS COMMERCIAL INSURANCE SERVICES, INC., a California corporation.
2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

ONE: The name of the corporation is Crump Commercial Insurance Services, Inc.

TWO: The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

THREE: This corporation is authorized to issue only one class of shares of stock; and the total number of shares which this corporation is authorized to issue is one thousand (1,000).


3. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment and restatement of the Articles of Incorporation has been duly approved by the required vote of shareholder in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is one thousand (1,000) shares of common stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
