TRADEMARK ASSIGNMENT

THIS AGREEMENT has an effective date of July ~~28~~²⁹, 2009.

Assignor further authorizes the appropriate authority or authorities whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors and assigns in accordance with the terms of this Agreement and at Assignee's expense.

At Assignee's request, Assignor further agrees to execute any and all documents necessary or desirable to properly vest full right, title and interest in and to the Trademarks throughout the world in the name of Assignee, its successors and assigns, and to perform any other reasonable acts at Assignee's expense generally necessary for Assignee to obtain, maintain, issue or enforce the Trademarks.

This Agreement may be executed in several counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument.




