## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of September 4, 2009 ("Effective Date") in favor of Wellman, Inc., a Delaware corporation ("Grantor") by Wilmington Trust Company, a Delaware banking corporation, as Collateral Agent and Trustee under each of the Indentures, dated as of January 30, 2009, by and among Wellman Holdings, Inc., as issuer, the guarantors party thereto and Wilmington Trust Company, as Collateral Agent and Trustee (in such capacities, the "Trustee").

**WHEREAS**, Grantor and the Trustee are parties to that certain Guaranty and Collateral Agreement by and between Grantor, the Trustee and the other parties thereto dated January 30, 2009 (the "Security Agreement");

**WHEREAS**, in connection with the Security Agreement, Grantor entered into those certain Trademark Security Agreements dated January 30, 2009 (the "Trademark Security Agreements") pursuant to which the Grantor granted the Trustee a security interest in and lien on the Trademark Collateral (as defined therein), including the trademarks set forth on Schedule A (the "Trademarks"); and

**WHEREAS**, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on January 31, 2009, at Reel/Frame 3927/0826 and on February 10, 2009, at Reel/Frame 3933/0312.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Trustee hereby (i) terminates, cancels and releases any and all security interests or liens it has against the Trademarks, and (ii) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademarks to Grantor.

The Trustee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
