ASSIGNMENT OF REGISTERED MARKS

WHEREAS, Le Cordon Bleu International B.V., a company incorporated in the Netherlands, registered at the Amsterdam Chamber of Commerce and Industry under number 33 180 420, having its registered office at Herengracht 28, 1015 BL Amsterdam, Netherlands ("Assignor"), is the owner in the U.S. and Canada of the common law rights in the trademarks LE CORDON BLEU, CORDON BLEU and other various trademarks incorporating the term "CORDON" in connection with a variety of goods and services (the "Marks").



WHEREAS, Assignor desires to retain the right, title and interest in, to and under the Registrations for all fields of use set forth therein other than educational services, as well as the parts of the Registrations that do not cover educational services.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby conclusively acknowledged, Assignor does hereby irrevocably sell, assign, transfer and set over to Assignee all its right, title and interest in, to and under the Marks covered by the Registrations for the field of use of educational services and the Registrations or parts thereof that cover educational services as specified in column five (5) of Exhibit A, together with the goodwill of the business symbolized by the Marks assigned hereunder, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past violation, said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor if this Assignment of Trademarks had not been made.

Assignor and Assignee agree that they shall execute such further documents, and perform such further acts, as may be necessary to transfer and convey rights assigned hereunder including without limitation dividing the Registrations such that the applicable portions thereof can be and are assigned to Assignee and the records of the trademark offices reflect such assignment and that the rights intended to be retained by Assignor can be and are retained by Assignor and the records of the trademark office reflect such intention.
