## ASSIGNMENT OF TRADEMARK

### TERMS

4. Compensation: Assignee agrees to pay \$10.00 to Assignor and to continue the prosecution of said trademark application and incur all related expenses as additional consideration for the assignment of Assignor's Trademark and all rights and interest stated herein.
5. Assignment of Assignor's Trademark and Goodwill: Assignor hereby assigns to Assignee all of Assignor's rights, title and interest, within the United States of America and throughout the world, in the Assignor's Trademark together with goodwill associated with and relating to the Assignor's Trademark. Assignor also assigns to Assignee all rights and interest, including all future interest, in the Assignor's Trademark, any applications and/or registrations arising from and in connection with the Assignor's Trademark. Assignor agrees to execute the Trademark Recordation Form which is attached hereto and made a part hereof as Schedule A.

### REPRESENTATIONS

6. Application: Assignor represents and warrants that he has prepared all application/s that have been filed or that are pending before applicable government agencies relating to the

Assignor's Trademark without misrepresentation and/or fraud in the application/s and to the applicable agencies.

7. Good Title and Authority: Assignor represents and warrants that he has valid, unencumbered, good and marketable title to the Assignor's Trademark, and to other rights assigned to Assignee pursuant to this Agreement. Assignor further represents and warrants that he has proper and full rights and authority to assign the Assignor's Trademark to Assignee.

POST-ASSIGNMENT OBLIGATIONS

8. Covenant of Further Assurances: Assignor hereby agrees to provide reasonable assistance to Assignee for a period of one (1) year from the date of this Agreement in (i) evidencing, recording and perfecting the assignment of the Assignor's Trademark contemplated by this Agreement, and (ii) applying for and obtaining recordation of, and from time to time enforcing, maintaining, and defending the Assignor's Trademark assigned herein, if requested by Assignee – all at the expenses of Assignee.
9. Succession and Assignment: This Agreement shall be binding upon and inure to the benefit of the parties named herein and their respective heirs, personal representatives, successors and assigns.
