**RELEASE OF SECURITY INTEREST**

THIS RELEASE OF SECURITY INTEREST made and entered into this 18th day of September, 2009, by CAPITAL ONE LEVERAGE FINANCE CORP., successor to North Fork Business Capital Corporation ("Lender"), in favor of GLOBAL TISSUE GROUP, INC. ("Borrower").
