## TRADEMARK ASSIGNMENT

WHEREAS, JTJ MEDICAL SUPPLY, INC., a corporation duly organized under the laws of Florida, having its principal offices at 3677 Central Avenue, Suite A, Ft. Myers, Florida 33901 (the "Assignor") has adopted, used and is using (1) the "Med Box Personalized Pill Box System" trademark, which was registered on the United States Patent and Trademark Office ("USPTO") Principal Register on November 20, 2007 and was assigned Registration No. 3,337,749 (the "Med-Box Mark") and (2) the "Mail-Meds Clinical Pharmacy" trademark, which was registered on the USPTO Principal Register on August 14, 2007 and was assigned Registration No. 3,278,411 (the "Mail-Meds Mark," and, collectively with the Med-Box Mark, the "Trademarks"), and has acquired goodwill in connection with such use of the Trademarks; and

WHEREAS, MED-BOX TECHNOLOGIES, INC., a corporation duly organized under the laws of Florida, having offices at 3677 Central Avenue, Suite A, Ft. Myers, Florida 33901 (the "Assignee") is desirous of acquiring all of Assignor's right, title, goodwill and interest in and to the Trademarks, including, without limitation, any registrations and applications thereof, in all countries of the world, including the United States of America and its territories and possessions.

NOW, THEREFORE, in consideration of, and in exchange for, one hundred (100) shares of the common stock, with a par value of \$0.01 per share, of the Assignee, Assignor hereby sells, assigns, transfers and conveys to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Trademarks, including, without limitation, any applications and registrations therefore, together with the goodwill of the business symbolized by the Trademarks, in all countries of the world including the United States of America and its territories and possessions, all causes of action for any and all past infringements of the rights being assigned hereunder and the right to collect and retain any proceeds received in connection therewith.

Assignor hereby expressly agrees to execute, acknowledge and deliver such other documents and instruments as may be reasonably requested by the Assignee to evidence and/or effectuate the sale, assignment, transfer, conveyance and delivery of the Trademarks to the Assignee.

IN WITNESS WHEREOF, Assignor has caused this trademark assignment to be executed as of this 17<sup>th</sup> day of September, 2009.
