RELEASE OF SECURITY INTEREST (TRADEMARKS)

Each Secured Party agrees to execute such other documents and assurances as may be reasonably necessary to carry out the intent of this Release of Security Interest.


This Release of Security Interest shall be binding upon each Secured Party and its successors and assigns.
