TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of the sum of \$10.00 and other good and valuable consideration exchanged by the parties, the receipt and sufficiency thereof is acknowledged, ASSIGNOR does hereby assign and transfer to ASSIGNEE, its successors and assigns, all rights, title and interest in the Marks, including, but not limited to, applications and registrations thereof, together with the goodwill of the business symbolized by said Marks, together with the right to sue for past, present or future infringement of said Marks, and to collect and retain damages and profits therefor, all of the foregoing to be held and enjoyed by ASSIGNEE for its own use and for the use of its successors, assigns or other legal representatives, together with all of the income, royalties, damages and payments now or hereafter due or payable with respect thereto.

ASSIGNEE's authority hereunder shall include, without limitation, the authority to execute and receive any certificate of ownership or other document to transfer title to any of the Marks assigned pursuant to this Trademark Assignment, and to take any other actions necessary or incident to the powers granted to ASSIGNEE in this Trademark Assignment.
