THIS TRUST AND AGREEMENT AND ASSIGNMENT FOR THE BENEFIT OF CREDITORS, is made and entered into this 14th day of April, 2009, by and between Global Accessories, Inc, a Delaware Corporation, located at 80 West 900 South, P.O. Box 3656, Logan, UT 84323-3656 (hereinafter referred to as "Global Accessories"), and Nancy A. Ross of HIGH RIDGE PARTNERS, INC., located at 140 South Dearborn Street, Suite 420, Chicago, Illinois 60603, not individually, but solely as Trustee-Assignee (hereinafter referred to as the "Trustee-Assignee").

WITNESSETH:




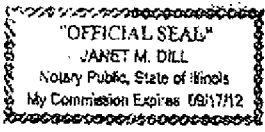
