- (2) All common-law and statutory rights with respect to said Intellectual Property.
- (3) All rights to bring legal action against any third party for and to recover damages in the United States for infringement of said Intellectual Property, including monetary damages for any past infringement.

- (4) All rights to bring legal action and/or suits in equity in the United States against any and all third party(ies) and to seek injunctive and/or other equitable relief and/or to recover monetary damages for unfair competition and/or other tortuous conduct by any third party relating to the business conducted under said Intellectual Property, including but not limited to damages for such past unfair competition and/or other tortuous conduct.
