- I. **WHEREAS** Contributor and Company are members of an international group of companies operative in the area of food and beverage (hereinafter referred to as "the Molinos Group");
- II. **WHEREAS** within the framework of the steps linked to an internal reorganization of its European business which the Molinos Group is currently implementing, Contributor is interested in assigning and transferring to Company by means of a contribution, and Company wishes be contributed with the Trademarks in accordance with the provisions of this Agreement;
- III. **WHEREAS** as of the Effective Date, Contributor is the legal and economic owner, and hence the registered holder, of the Trademarks, duly registered in the relevant Trademark Registers of the corresponding Territory, and is therefore in a position to contribute them to Company.

NOW THEREFORE in consideration of the mutual covenants and agreements hereinafter contained and for other good and valuable consideration (the receipt and sufficiency of which is acknowledged by each of the parties hereto) the parties covenant and agree each with the other as follows:

II. DEFINITIONS AND INTERPRETATION

A. DEFINITIONS

In this Agreement, in addition to the terms defined and capitalized throughout the Agreement, the following terms have the meanings specified or referred to in this Chapter II:

- "Agreement" means the present Contribution Agreement together with its Exhibits
- "Applicable Trademark Authorities" means the competent trademark authorities in the corresponding Territory for the registration of trademarks
- "Company" means *Molinos IP S.A.*
- "Contributor" means Molinos Rio de la Plata, S.A.
- "Dollars" or "US\$": means the legal currency of the United States of America.
- "Effective Date" means the date specified in Article 3 below.
- "Parties" means Contributor and Company.

- "Territory" or "Territories" means the territory or territories for which Trademarks are registered in the corresponding Trademark Registers.
- "Trademarks" means the trademarks specified in EXHIBIT 1 to this Agreement registered in the Territories described in said Exhibit 1, as well as any other trademarks, combination, trademarks set, label design, printed items on packaging, design, slogans, words, advertising phrases, logos or any other sign suitable for distinguishing products or services on the market, owned by Contributor and which are related to the Trademarks, whether registered or in the process of being registered with the Applicable Trademark Authorities in the corresponding Territory.
- "Trademark Register" shall mean the official register of trademarks in each of the Territories.

B. INTERPRETATION

For the purposes of the interpretation of this Agreement, the Parties agree that:

- The capitalized terms in the present Agreement and Exhibits hereto (other than at the start of a sentence or relating to a proper noun), have the meanings assigned to them in Section A hereabove.
- As required by the context, the words in the singular include the plural and the words in the plural include the singular.
- The content and headings of the Sections and Articles shall have no effect on the interpretation of the present Agreement.
- Each legal term that is not otherwise defined in the present Agreement has the meaning assigned to the same in accordance with Swiss legislation.

III. COVENANTS

ARTICLE 1 CONTRIBUTION

Contributor hereby contributes and consequently transfer the Trademarks to Company in the form of contributed surplus to be booked into Company's free reserves (hereinafter "the Contribution").

The Contribution described above is subject to the terms and conditions set forth in this Agreement and shall be made by the parties hereto on the Effective Date.

ARTICLE 2 TRADEMARKS

For the purpose of this Agreement, "Trademarks" shall mean the trademarks as described in EXHIBIT 1 registered in the Territories described in the said Exhibit 1, including without limitation all registrations and applications which exist at the Effective Date with respect to the Trademarks in the corresponding Territories and all powers and authorities to renew any registration, initiate, pursue and terminate administrative and / or judicial actions, answer claims, commence proceedings owing to infringements, reply to administrative, judicial and / or non-judicial claims relating to the Trademarks and use them and benefit from them through ownership.

EXHIBIT 1 contains a clear specification and identification of each Trademark as well as a specification of the Territory in which the Trademark is registered or has been applied for registration.

ARTICLE 3 EFFECTIVE DATE

This Agreement shall be effective among the parties as of July 1st 2008, which is and shall be deemed to be "the Effective Date".

The foregoing covenant shall be understood without prejudice of any other date which might be the date as from which this contribution will be opposable to third parties as a consequence of its registration with the Applicable Trademark Authorities. The parties hereto commit however to act towards each other as from the Effective Date in the manner that they would if the registration of the Trademarks had been completed on the Effective Date.

ARTICLE 4 VALUE OF THE CONTRIBUTION

The value which both parties in common understanding and based on a third party valuation known to them and accepted as correct, are agreeable that the value of the Trademarks, and therefore the value for which the Trademarks is contributed by Contributor to Company amounts to US \$ 49.767.000 (forty nine millions and seven hundred and sixty seven thousand dollars of the united states of america) (hereinafter "the Contributed Value").

ARTICLE 5 LACK OF CONSIDERATION

Without prejudice of both parties' agreement about the Contributed Value, the Contribution is made free of consideration and therefore Company is not due at the Effective Date and shall not be due at any time in the future to compensate Contributor for the Contribution.

ARTICLE 6 LEGAL AND ACCOUNTING NATURE OF THE CONTRIBUTION

On the Effective Date the Contribution shall be booked in Company's books as a surplus, i.e. as a contribution into Company's reserves, and Company hereby expressly undertakes not to book the Contribution in its profit and loss accounts but to allocate it exclusively to the free reserves.

ARTICLE 5 CONTRIBUTOR'S REPRESENTATIONS

Contributor represents and warrants to Company as follows:

5.1 As to Contributor

- (a) Contributor is a limited public company duly registered and validly existing under the laws of Argentina.
- (b) All authorisations, approvals and consents necessary for the execution and delivery of this Agreement by Contributor, and the execution of the transactions contemplated hereby, if any, have been given; Contributor has the full right, power and authority to enter into and perform the terms and conditions of this Agreement.
- (c) Completion, execution and compliance with the present Agreement does not entail the infringement of Contributor's by-laws or any applicable legislation, or non-compliance or causes non-compliance of any other contract, agreement or according to which it is or it may be a party.
- (d) Contributor is the sole legal and beneficial owner of the Trademarks and at as of the Effective Date the Trademarks are duly registered with the Applicable Trademark Authorities in the corresponding Territories and are free of claims of third parties liens, encumbrances and charges and will be transferred to Company together with all rights attaching and accruing thereto.

5.2 As to the Trademarks

- a) The trademarks detailed in EXHIBIT 1 constitute all the trademarks registered or in use by Contributor or pending registration in the Territories listed in EXHIBIT 1 connected with the Trademarks.
- b) The Trademarks identified in EXHIBIT 1 have been used in the corresponding Territory in the past 5 (five) or 3 (three) years according to the applicable legislation in each of the Territory. For such purposes, it is understood that the Trademarks have been used when the products which are differentiated by the same have been traded or are available on the market under that Trademarks.
- c) The Trademarks hereunder are fully in effect and valid, with all the renewals having been secured and all maintenance and renewal fees having been paid to date.
- d) The Trademarks are not subject to a claim, option, pledge, encumbrance, better right, limitation, restriction or hindrance of any kind which may in any way affect, stop, limit, hinder or restrict its free availability, transfer, registration, licence and / or use in accordance with the provisions hereof.
- e) No third party is infringing nor has misappropriated the Trademarks.
- f) Except for the trademark "Matarazzo" in Brazil, no notification has been received by Contributor, questioning the validity of the Trademarks.
- g) EXHIBIT 2 sets out a list which includes (i) the objections raised on the basis of the Trademarks against third-party trademarks applications and (ii) the objections and / or appeals submitted by third parties to the applications or registrations related to the Trademarks in the corresponding Territory.
- h) Contributor has no applications and / or has granted no Trademarks applications or registrations which may be analogous, similar or confusable with the Trademarks in the corresponding Territory. Moreover, if there are applications and

/ or trademarks in its name which are identical, similar or confusable with the Trademarks in the corresponding Territory, the same shall be considered transferred in favour of Company, triggering no entitlement to any additional compensation whatsoever.

- i) No authorisation, approval or any other action by central government, other overseeing body or Applicable Trademark Authority or any notification from the same or a third party is requisite for the appropriate completion, execution and compliance of the present Agreement
- j) The Contributed Value is the real and effective value of the contributed Trademarks.
- k) Contributor has paid all the taxes whose non-payment could have a negative effect on the use, operation or enjoyment of the Trademarks by Company.

5.3 Not other Representations and Warranties

Except for the representations and warranties made herein, Contributor makes no other representations and warranties of any kind.

ARTICLE 6 COMPANY'S REPRESENTATIONS

Company represents and warrants to Contributor as follows:

- (a) Company is a company limited by shares duly registered and validly existing under the laws of Switzerland;
- (b) All authorisations, approvals and consents necessary for the execution and delivery of this Agreement by Company and the execution of the transactions contemplated hereby, if any, have been given; Company has the full right, power and authority to enter into and perform the terms and conditions of this Agreement;
- (c) Completion, execution and compliance with the present Agreement does not entail the infringement of Company's by-laws or any applicable legislation, or non-compliance or causes non-compliance of any other contract, agreement or according to which it is or it may be a party.

Except for the representations and warranties made herein, Company makes no other representations and warranties of any kind.

ARTICLE 7 CONTRIBUTOR'S ANCILLARY OBLIGATIONS

7.1 General

Contributor hereby commits to carry out all actions and legal steps in any and all jurisdictions which might be applicable and which might be necessary in order to fully implement the contents of this Agreement.

7.2 Specific Obligations

On the Effective Date, or as soon thereafter as shall be reasonable and practicable, Contributor shall:

- (i) deliver to Company the original titles and certificates of the Trademarks;
- (ii) deliver to Company original evidence of the new applications and / or applications for the renewal of the Trademarks submitted to the Applicable Authorities in the Territory;
- (iii) deliver to Company evidence of the objections submitted, based on the Trademarks in the corresponding Territory and in relation to the Trademarks applications submitted by third parties;
- (iv) sign the document attached hereto as **Exhibit 3**, additionally Contributor shall at the request of the Company do all acts and execute all documents to ensure that all the rights and title to and interest in the Trademarks is fully conveyed..
- (v) deliver to Company all other necessary documentation to register the transfer of the Trademarks with the Applicable Trademark Authorities in the corresponding Territory.

7.3 Future Obligations in connection with the Trademarks

Contributor agrees that at any time after the date of Effective Date, at Company's first request and for no additional consideration, it shall sign and deliver, itself or through third parties, whatever additional instruments, assignments, certificates, deeds might be required and shall carry out whatsoever acts may be necessary or convenient in order to effect and complete the contribution and transfer of ownership of the Trademarks. It further commits to support Company in whatever assistance it might need in order to complete whatever actions are necessary in order to implement and fully effect this Agreement.

7.4 Other registrations

Contributor undertakes in the future to:

- (i) not to effect any questioning or claim in relation to the ownership, renewal and / or validity of the Trademarks and / or combinations of the Trademarks in the corresponding Territory or assist third parties in doing so; and
- (ii) not to register or attempt to register and / or use in the corresponding Territory trademarks analogous or confusable with the Trademarks in any kind of trademark nomenclature.

ARTICLE 8 COSTS AND TAXES

8.1 Costs

The costs and expenses, fees or levies of any kind which may result from the registration of Company's ownership of the Trademarks the Applicable Trademark Authorities shall be borne solely by Company.

Without prejudice of the foregoing provision, each of the Parties shall bear its own costs and expenses (including but without limitation to all remuneration and fees of external advisors, financial advisors, consultants, notaries and accountants and external auditors) incurred in relation to the preparation and execution of this Agreement and the completion of the transactions envisaged by the present Agreement or required by operation of law.

8.2 Taxes

In the event any tax becomes due by reason of this Agreement, such tax shall be borne by the party upon whom such tax is imposed by applicable law.

ARTICLE 9 GOVERNING LAW AND ARBITRATION

This Agreement shall be governed by the laws of Switzerland, without prejudice of the fact that some of the legal actions directly related to the registration of the transfer of the Trademarks with the Applicable Trademark Authorities in the corresponding Territory might be compulsorily governed by the law applicable to the Trademarks. In this case, and only to the extent that the application of any law other than Swiss law was compulsory, the parties hereto agree to have such actions governed by the corresponding law applicable to the Trademarks.

All disputes arising in connection with this Agreement shall be finally settled under the Rules of Arbitration of the International Chamber of Commerce by a majority of three arbitrators appointed in accordance with said rules. Arbitration shall take place in Zurich, Switzerland and language of arbitration shall be English. Judgement upon award rendered by the arbitrators may be entered in any court having jurisdiction thereof.

ARTICLE 10 AMENDMENTS

No amendment to this Agreement shall be binding upon any party unless it is in writing and is signed by both parties. This Agreement supersedes any prior agreements between the parties concerning the subject matter herein.

ARTICLE 11 ASSIGNMENT

No party may assign any of its rights or delegate any of its duties under this Agreement without first obtaining written consent of the other party.

ARTICLE 12 SEVERABILITY

If any provision of this Agreement is held to be unenforceable, this Agreement shall be considered divisible and such provision shall be deemed inoperative to the extent it is deemed unenforceable, and in all other respects this Agreement shall remain in full force and effect; provided, however, that if any such provision may be made enforceable by limitation thereof, then such provision shall be deemed to be so limited and shall be enforceable to the maximum extent permitted by applicable law.

Any notice under this Agreement shall be in writing and shall be effective when received by the addressee at its address as indicated above.


