Ladies and Gentlemen:

Reference is made to (a) the Revolving Credit Agreement, dated as of July 24, 2007 (as amended to date, the "Revolving Credit Agreement"), among The ServiceMaster Company, a Delaware corporation (the "Company"), certain subsidiaries of the Company, the several banks and other financial institutions from time to time party thereto (collectively, the "Lenders"), Citibank, N.A., as administrative agent, collateral agent and issuing bank and JPMorgan Chase Bank, N.A., as syndication agent and (b) the Guarantee and Collateral Agreement, dated as of July 24, 2007 (the "Guarantee and Collateral Agreement"), made by the Company and certain Subsidiaries of the Company in favor of Citibank N.A. as Administrative Agent and Revolving Collateral Agent (in such capacities, the "Agent"). Capitalized terms used but not defined herein shall be defined as in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable.

1. Transaction. The Company hereby notifies the Agent that it has reached an agreement to sell the trademarks and service marks set forth on exhibit A hereto (the "Trademarks") to Gogreen, Inc. (the "Transaction") for a gross cash purchase price of approximately \$6,000. The Company does not expect to incur any expenses in connection with the Transaction. The Transaction is scheduled to close on or around September 17, 2009.

2. Request for and Confirmation of Release. In connection with the consummation of the Transaction and in accordance with the Loan Documents:

(a) The Company hereby certifies that the Transaction is in compliance with the Revolving Credit Agreement and the other Loan Documents.


(b) The Company hereby requests the release and delivery to it of all of the Security Collateral sold or disposed of in connection with the Transaction (the "Released Assets").

(c) The Agent hereby acknowledges, agrees and confirms that, effective upon the closing of the Transaction, the Lien on and security interest in the Released Assets pursuant to the Loan Documents is automatically released. Such acknowledgement, agreement and confirmation is made in reliance on the notice and certification of the Company set forth above, pursuant to Section 9.2 of the Revolving Credit Agreement, and the Agent has not made any independent investigation of the matters set forth in such notice.


