2. The following amendment to the Company's Articles of Organization was adopted by the vote required by section 183.0404(2) of the Wisconsin Statutes:


Article I of the Articles of Organization is hereby amended to read in its entirety as follows:

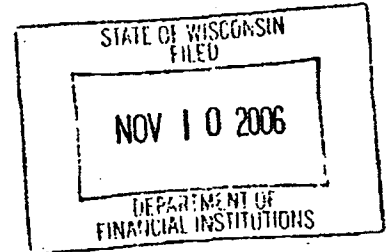
