**ASSIGNMENT AND ASSUMPTION OF SECURITY INTEREST IN TRADEMARKS**

**ASSIGNMENT AND ASSUMPTION OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 28, 2009 (this "Assignment"), among Lehman Commercial Paper, Inc., as resigning administrative agent ("LCPI" or the "Resigning Administrative Agent"), Bank of America, N.A., as successor administrative agent (the "Successor Administrative Agent") and Quality Gift Distributors, Inc. and The Yankee Candle Company, Inc. (each a "Grantor" and together the "Grantors").

**WITNESSETH:**

WHEREAS, pursuant to the Credit Agreement, dated as of February 6, 2007 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among the Grantors, Yankee Holding Corp., Yankee Acquisition Corp., the several banks and other financial institutions or entities from time to time parties thereto (the "Lenders"), Merrill Lynch Capital Corp., as Syndication Agent, Sovereign Bank and Wells Fargo Retail Finance, LLC as Co-Documentation Agents, and Lehman Brothers Inc. and Merrill Lynch, Pierce, Fenner & Smith Inc., as Joint Lead Arrangers and Joint Book Runners and the Resigning Administrative Agent, as Administrative Agent, the Lenders have severally agreed to make extensions of credit to the Grantors upon the terms and subject to the conditions set forth therein;

WHEREAS, the Grantors are party to a Guarantee and Collateral Agreement, dated as of February 6, 2007 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "G & C Agreement"), in favor of the Resigning Administrative Agent, as the original administrative agent pursuant to which the Grantors executed and delivered a Short-Form Trademarks Security Agreement, dated as of February 6, 2007 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement and to the extent provided in the G & C Agreement (the terms and conditions of which are hereby incorporated herein), the Resigning Administrative Agent, as the original administrative agent, was granted, for the ratable benefit of the Resigning Administrative Agent and the Lenders, a security interest in all of the Trademarks now owned or at any time hereafter acquired (including, without limitation, those items listed on Schedule I of Registered Trademarks hereto) by the Grantors as more fully described therein;

WHEREAS, on October 5, 2008, LCPI commenced a voluntary case under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") and on such date, pursuant to section 362(a) of the Bankruptcy Code, an automatic stay went into effect that prohibits actions to interfere with, or obtain possession or control of, LCPI's property or to collect or recover from LCPI any debts or claims that arose before such date;

WHEREAS, on October 6, 2008, the United States Bankruptcy Court for the Southern District of New York entered an order (the "Bankruptcy Court Order") in the bankruptcy case of LCPI authorizing and empowering LCPI to transfer, assign or resign from any administrative agent positions in LCPI's business judgment in accordance with the provisions of any applicable credit agreements and in accordance with the Bankruptcy Court Order;

WHEREAS, pursuant to the Amendment, Waiver, Resignation and Appointment Agreement, dated as of the date hereof (the "Amendment Agreement"), among the Resigning Administrative Agent, the Successor Administrative Agent, the Required Lenders, the Grantors, and Yankee Holding Corp., the Credit Agreement has been amended to reflect the appointment of the Successor Administrative Agent as successor administrative agent; and

WHEREAS, in furtherance of the Successor Administrative Agent's replacement of the Resigning Administrative Agent as the Administrative Agent under the Credit Agreement and the G & C Agreement, the Successor Administrative Agent desires to acquire and the Resigning Administrative Agent desires to assign all of its right, title and interest in, to and under the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Resigning Administrative Agent, the Successor Administrative Agent and the Grantors hereby covenant and agree as follows:

### **Defined Terms**

Unless otherwise defined herein, terms defined in the Credit Agreement, the G & C Agreement or the Trademark Security Agreement and used herein have the meaning given to them in the Credit Agreement, the G & C Agreement or the Trademark Security Agreement, respectively.

### **Assignment of Trademark Security Agreement**

The Resigning Administrative Agent hereby assigns, transfers and conveys to Successor Administrative Agent all of its right, title and interest in, to and under the Trademark Security Agreement, including the security interest in all of the Grantors' rights, titles and interests in, to and under all of the Trademarks, whether now owned or at any time hereafter acquired, that are registered with, or for which applications for registrations have been filed with, the United States Patent and Trademark Office, including the those Trademarks identified in Schedule I of Registered Trademarks attached hereto, all registrations and pending applications associated therewith (but excluding any application for registration of a trademark filed on an intent-to-use basis to the extent that the grant of a security interest in any such trademark application would adversely affect the validity or enforceability of the resulting trademark registration or result in cancellation of such trademark application) as collateral security for the prompt and complete payment and performance when due of the Borrower Obligations, as such term is defined in the G & C Agreement. Notwithstanding the foregoing, in the event of any conflict between this Assignment and the G & C Agreement, the G & C Agreement shall control.

The Successor Administrative Agent hereby accepts the foregoing assignment and assumes the obligations of the Resigning Administrative Agent under the Credit Agreement, the G & C Agreement and the Trademark Security Agreement, on and after the date hereof.

### **Guarantee & Collateral Agreement**

The security interest granted to the Resigning Administrative Agent as the original Administrative Agent pursuant to the Trademark Security Agreement, and assigned to the



Successor Administrative Agent as the new Administrative Agent pursuant to this Assignment, is granted and assigned in conjunction with the security interest granted to the Resigning Administrative Agent pursuant to the G & C Agreement, and all parties hereto hereby acknowledge and affirm that the rights and remedies of the Resigning Administrative Agent with respect to the security interest in the Trademarks made and granted by the Trademark Security Agreement and assigned hereby are more fully set forth in the G & C Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

### **Recordation**

The parties hereto authorize and request the Commissioner of Patents and Trademarks of the United States and/or any equivalent state official to record this Assignment against the Trademarks identified on Schedule I of Registered Trademarks attached hereto.

### **Counterparts**

This Assignment may be executed in multiple counterparts (including telecopy or other electronic transmission), each of which shall be considered an original but all of which shall constitute one agreement.


