**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), is dated as of September 25, 2009, and made by **ARES CAPITAL CORPORATION**, a Maryland corporation in its capacity as agent for the benefit of lenders under that Security Agreement referred to below ("Grantee") to **WASTE PRO USA, INC.**, a Florida corporation ("Holdings"), **WASTE PRO OF FLORIDA, INC.**, a Florida corporation ("Florida"), **WASTE PRO OF GEORGIA, INC.**, a Georgia corporation ("Georgia"), **AMERICAN TRANSPORTATION SERVICES, LLC**, a Georgia limited liability company ("ATS"), **AMERICAN RECYCLING OF GEORGIA, LLC**, a Georgia limited liability company ("ARG"), **AMERICAN RECYCLING OF ALABAMA, LLC**, an Alabama limited liability company ("ARA"), **AMERICAN RECYCLING, LLC**, a Georgia limited liability company ("AR") and **WASTE PRO OF SOUTH CAROLINA, INC.**, a South Carolina corporation ("SC" and together with Holdings, Florida, Georgia, ATS, ARG, ARA and AR, the "Grantors" and each individually a "Grantor").

WHEREAS, pursuant to that certain Security Agreement dated as of November 9, 2006, by and among Holdings, Florida, Georgia, SC and Grantee (as amended or otherwise modified from time to time, whether by joinder agreement or otherwise, the "Security Agreement"), a security interest was granted by Holdings, Florida, Georgia and SC to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 15, 2006 at Reel 003428 and Frame 0438;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 27, 2009 by and among the Grantors and Grantee (the "Trademark Security Agreement"), the Grantors granted to Grantee a continuing security interest in the Trademarks (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 3, 2009 at Reel 003945 and Frame 0328; and

WHEREAS, Grantee now desires to terminate and release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
3. Representations and Warranties. Grantee represents and warrants that (i) it has full power and authority to execute this Termination and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement and Trademark Security Agreement.
4. Further Assurances. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Trademarks.
