RELEASE OF SECURITY INTEREST IN TRADEMARKS

RECITALS

WHEREAS Sonoma Foods, Inc. ("SF") and Rumiano entered into a Security Agreement dated February 23, 2003 ("Security Agreement");

WHEREAS the Security Agreement secured the payment to Rumiano of the obligations of SF to pay Rumiano for cheese products manufactured and supplied by Rumiano to SF; and

WHEREAS SF has paid the amount due to Rumiano which is secured by the Security Agreement and Rumiano has accepted such payment as payment in full of the secured obligations and is willing to release its security interest created by the Security Agreement.

NOW THEREFORE, RUMIANO DOES HEREBY RELEASE AND AGREE AS FOLLOWS:

1. Rumiano does hereby release and discharge any and all security interests of whatsoever kind or nature that exist pursuant to the Security Agreement. Rumiano's release and discharge of any and all security interests is effective immediately. Rumiano agrees to sign and provide SF with any documents reasonably requested by SF necessary to release of record any security interests. SF is authorized and to arrange to put of record the release of Rumiano's security interests. Without limiting the foregoing, the specific items on which the security interest was granted by the Security Agreement and to which the release of security interest granted herein specifically applies are as follows:
