RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of September 30, 2009 granted by CITICORP NORTH AMERICA, INC., a national association, located at 233 S. Wacker Drive, 86th Floor, Chicago, IL, in its capacity as administrative agent pursuant to the Credit Agreement (in such capacity, the “Administrative Agent”) in favor of ACCO Brands Corporation, a Delaware corporation, located at 300 Tower Parkway, Lincolnshire, IL, ACCO Brands USA LLC, a Delaware limited liability company, located at 300 Tower Parkway, Lincolnshire, IL, Day-Timers, Inc., a Delaware corporation, Swingline, Inc., a Delaware corporation, located at 300 Tower Parkway, Lincolnshire, IL, Boone International, Inc., a Delaware corporation, located at 300 Tower Parkway, Lincolnshire, IL, General Binding Corporation, a Delaware corporation, located at 300 Tower Parkway, Lincolnshire, IL, and VeloBind, Incorporated a Delaware corporation, located at 300 Tower Parkway, Lincolnshire, IL, (each individually, a “Pledgor”, and collectively, the “Pledgors”).

WHEREAS, the Pledgors and the Administrative Agent entered into a Security Agreement dated as of August 17, 2005 (as amended, supplemented or otherwise modified, the “Security Agreement”) pursuant to which the Pledgors were required to execute and deliver the Trademark Security Agreement;

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement, dated as of August 17, 2005 between the Pledgors and the Administrative Agent (as amended, supplemented or otherwise modified, the “Trademark Security Agreement”; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement or Security Agreement, as applicable), each Pledgor pledged and granted to the Administrative Agent a lien on and security interest in all of its right, title and interest in, to and under the following Pledged Collateral of such Pledgor (collectively, the “Trademark Collateral”):

(a) Trademarks of such Pledgor including, without limitation, the Trademark registrations and applications set forth on Schedule I hereto together with the goodwill associated therewith; and

(b) all Proceeds of any and all of the foregoing (other than Excluded Property).

WHEREAS the Trademark Security Agreement has been recorded with the Assignments Division of the U.S. Patent and Trademark Office on January 19, 2006 at Reel 3248 and Frame 0459; and

WHEREAS certain Supplemental Trademark Security Agreements were recorded with the Assignments Division of the U.S. Patent and Trademark Office on February 5, 2009 at Reel 3930 and Frame 447, March 9, 2009 at Reel 3948 and Frame 475, June 8, 2009 at Reel 4000 Frame 192 and August 26, 2009 at Reel 4053 Frame 068; and

WHEREAS the Pledgors have paid all of their outstanding indebtedness under the Credit Agreement which is secured by the Security Agreement and has requested that the Administrative Agent release its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all of its liens on and security interests in all of each Pledgor's right, title and interest in, to and under the Trademark Collateral, without warranty or recourse.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the Pledgors.

The Administrative Agent hereby authorizes the Pledgors or their authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of the Administrative Agent in the Patents, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

The Administrative Agent shall take all further actions, and provide to the Pledgors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the law of the State of New York.
