**NOTICE OF TRADEMARK SECURITY AGREEMENT**  
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of October 1, 2009, is made with regard to FAMILY TIME SNACKS, an Indiana corporation, whose address and principal place of business is 463 East Highway 30, Valparaiso, Indiana 46383 (the “Debtor”), by FIRST BUSINESS CAPITAL CORP., a Wisconsin corporation, whose address and principal place of business is 401 Charmany Drive, Madison, Wisconsin 53719 (the “Secured Party”).

R E C I T A L S:

The Debtor’s affiliate, Great Lakes Packaging, Inc. (“Great Lakes”), and the Secured Party have entered into a Loan and Security Agreement dated as of October 1, 2009 (as the same may hereafter be amended, supplemented or restated from time to time, the “Loan Agreement”), setting forth the terms on which the Secured Party may now or hereafter make certain loans or other financial accommodations to or for the account of Great Lakes.

As a further condition to making any loan or other financial accommodation under the Loan Agreement or otherwise, the Secured Party has required the execution and delivery of a Trademark Security Agreement by the Debtor.



IN WITNESS WHEREOF, the undersigned has executed this Notice of Trademark Security Agreement as of the date written above.


