RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on September 30 2009, by JPMORGAN CHASE BANK, N.A., as administrative agent (in such capacity, the "Administrative Agent") to UNDER SEA INDUSTRIES, INC., a Delaware corporation (the "Grantor").

WHEREAS, on May 29, 2009, the Grantor and the Administrative Agent entered into an Amended and Restated Pledge and Security Agreement ("Security Agreement") and a Confirmatory Grant of Security Interest in United States Trademarks ("Confirmatory Grant");

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, the Grantor granted to the Administrative Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");

NOW THEREFORE, as the Grantor has satisfied its obligations under said Security Agreement and Confirmatory Grant, the Administrative Agent hereby releases its security interest in and lien upon the Marks, and reassigns any and all interest it may have in the Marks to the Grantor.
