**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**, dated October 20, 2006 by **BACK BAY CAPITAL FUNDING LLC**, a Delaware limited liability company, in its capacity as Administrative Agent for the Lenders (as defined below) (the "**Administrative Agent**"), in connection with the Term Loan and Security Agreement, dated as of November 18, 2003 (the "**Loan Agreement**", capitalized terms used but not defined herein have the meanings assigned to them in the Loan Agreement), by and among Beaulieu Group, LLC (the "**Borrower**"), the financial institutions from time to time party thereto (the "**Lenders**") and the Administrative Agent.

**WHEREAS**, the Borrower and the Administrative Agent entered into a Trademark Security Agreement, dated as of November 18, 2003 (the "**Trademark Agreement**"), which Trademark Agreement was recorded June 21, 2006 with the United States Patent and Trademark Office at Reel 003335, Frame 0482 for the purpose of securing payment and performance of the Obligations;

**WHEREAS**, pursuant to the Loan Agreement and the Trademark Agreement the Borrower granted, assigned, transferred and conveyed to the Administrative Agent, by way of collateral security, all of the Trademarks and Licenses (as defined in the Trademark Agreement) as security for the Obligations;


**WHEREAS**, as the Obligations have been paid in full, the Administrative Agent has agreed to terminate and release the Trademark Agreement and assign and transfer to the Borrower its right, title and interest in the Trademarks and Licenses as herein provided;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates and releases the Trademark Agreement and assigns and transfers to the Borrower, without representation, warranty or recourse, all of the Administrative Agent's right, title and interest in and to the Trademarks and Licenses, including, without limitation, the Trademarks and Licenses listed on Exhibit A attached hereto, effective as of the date set forth above.

This Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts without giving effect to the conflict of laws principles thereof.


