IN WITNESS WHEREOF, Chaosium, Inc. has executed and delivered this Release as of the date first set forth above.

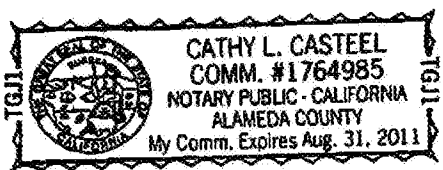
