- 1. SemMaterials hereby assigns unto Crafc0 all SemMaterials' right, title, and interest in and to the Trademarks, together with the good will of the business symbolized by the Trademarks.
- 2. SemMaterials agrees to sign any other documents or other instruments necessary to secure to and vest in Crafc0, its successors or assigns the entire right, title and interest in and to the Trademarks.

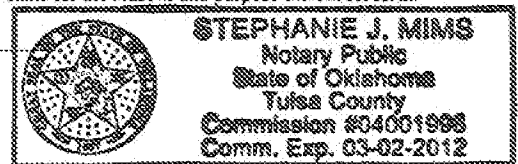

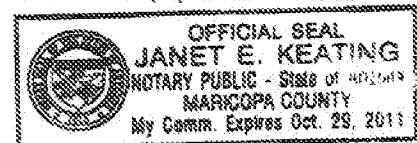
