## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made effective as of October 5, 2009, by 10<sup>th</sup> LANE FINANCE CO., LLC, a Delaware limited liability company, as agent (the "Agent"), as successor in interest to HBK INVESTMENTS L.P., a Delaware limited partnership ("HBK"), to BERKLEY INDUSTRIES, LLC, a California limited liability company ("Parent") and PACKAGING PLUS, LLC, a California limited liability company (the "Company" and together with Parent, the "Grantors") pursuant to the Payoff Confirmation Letter, dated as of October 5, 2009 (the "Payoff Letter"), among the Agent, Parent, the Company, Bank of America, N.A., as New Revolving Lender, and Cyan Partners, L.P., as New Term Lender and Administrative Agent.

WHEREAS, on March 30, 2007, the Grantors and the Agent entered into a Trademark Security Agreement ("Security Agreement");

WHEREAS, pursuant to said Security Agreement, the Grantors granted to the Agent, among other collateral, a continuing security interest in all of the Grantors' right, title and interest, in, or to, the United States Trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, said Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on March 30, 2007, at Reel 03511 and Frame 0663;

WHEREAS, on July 2, 2009, HBK and Agent entered into an Intellectual Property Assignment and Assumption Agreement ("Assignment and Assumption Agreement");

WHEREAS, pursuant to said Assignment and Assumption Agreement, HBK transferred all of its right, title and interest in and to the Trademarks, including its security interest in and lien upon the Trademarks, to the Agent; and

WHEREAS, said Assignment and Assumption Agreement was recorded with the USPTO on July 22, 2009, at Reel 04028 and Frame 0894.

NOW THEREFORE, pursuant to the terms of the Payoff Letter, the Agent hereby releases, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, and at the Grantors' sole cost and expense, all right, title and interest in and to the Trademarks, including its security interest in and lien upon the Trademarks, and any right, title or interest of Agent in such Trademarks shall hereby cease and become void.
