TRADEMARK ASSIGNMENT

WHEREAS, UNITED CUTLERY CORPORATION, a Georgia corporation having its principal place of business at 201 Plantation Oak Drive, Thomasville, Georgia 31792 (hereinafter "ASSIGNOR"), is the owner of all rights in the trademark WOLFHOUND and U.S. Trademark Registration No. 2,771,383 issued on October 7, 2003 (hereinafter, the "Trademark") and adopted and used by the ASSIGNOR in its business; and

WHEREAS, BUD K WORLD WIDE, INC., a Georgia corporation having its principal place of business at 475 US Highway 319 S, Moultrie, Georgia 31768-0508 (hereinafter, "ASSIGNEE"), is desirous of obtaining the entire right, title and interest in, to and under the aforesaid Trademark;

1. NOW, THEREFORE, for good and valuable consideration received by ASSIGNOR, ASSIGNOR hereby sells, assigns, transfers, and sets over unto the said ASSIGNEE the entire right, title and interest in and to the Trademark, together with the goodwill of ASSIGNOR'S business connected with the use thereof and symbolized by the Trademark, for ASSIGNEE'S own use and the benefit of its successors and assigns.

2. ASSIGNOR covenants that, upon ASSIGNEE'S request, ASSIGNOR will sign all lawful papers and make all rightful oaths that ASSIGNEE may deem necessary or desirable to perfect and record title to the Trademark in the United States Patent and Trademark Office.

3. ASSIGNEE shall retain the exclusive right to bring and maintain actions for, and to settle, release and compromise claims for infringement of, the Trademark occurring prior to the date hereof and to retain the proceeds thereof.

4. Except as otherwise expressly provided herein, no obligation is hereby assumed by ASSIGNOR to maintain, prosecute, enforce, litigate concerning, assert or defend the Trademark or to file any document with respect thereto.
