RECORDABLE TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is made and entered into this 7th day of October, 2009 ("Effective Date"), by and between Advanced Biotechnologies Company, LLC, an Indiana limited liability company, with a registered address of 322 South Main Street, Suite 200, Sheridan, Indiana 46069 ("ABC") and Agtech Products, Inc., a Wisconsin corporation with principal offices at W227N752 Westmound Drive, Waukesha, Wisconsin 53186 ("Agtech").

RECITALS:

- A. ABC is the owner of the ADSERO, ADSERO (& Design) and ADSERO SURVIVE AND THRIVE (& Design) trademarks and the related federal registration and application (respectively, U.S. Serial Nos. 78/971,690 and 78/971,684)("Trademarks").
- B. ABC desires to assign the Trademarks and all the rights and goodwill associated with the Trademarks to Agtech, and Agtech desires to accept such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

AGREEMENT:

1. **Assignment.** The parties acknowledge that ABC and Agtech entered into a Capital Unit Purchase Agreement, effective September 30, 2008, wherein Agtech acquired all ownership interests in ABC. ABC now hereby assigns to Agtech all right, title and interest in and to the Trademarks, including all common law rights thereto and any related trademark applications and registrations, together with the good will of the business symbolized by said Trademarks, and in and to any and all causes of action, either in law or in equity, and the right to enforce any rights and to file any causes of action, including the right to recover damages, for any past, present or future infringement or misappropriation of said Trademarks.
2. **Acceptance.** Agtech hereby accepts such assignment and transfer described in Section 1 and assumes all ownership, rights, liabilities and obligations in connection with such assignment.
3. **Cooperation:** ABC agrees to execute any and all reasonable assignments, affidavits, and any other papers reasonably necessary to further perfect Agtech's rights in the Trademarks.
4. **Applicable Law and Jurisdiction.** This Assignment shall be governed by and construed in accordance with the laws of the State of Wisconsin. Any suit related to this Assignment must be brought in the United States District Court for the Western District of Wisconsin. The parties acknowledge that each party, in connection with the making of this Assignment, has had sufficient contacts with the state of Wisconsin so that the United States District Court for the Western District of Wisconsin shall have personal jurisdiction over both parties to hear any action arising under this Assignment.

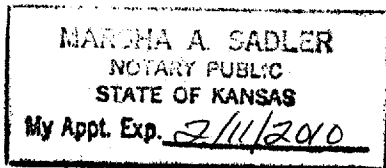
