**TERMINATION AND RELEASE OF SECURITY INTERESTS
IN TRADEMARKS**

WHEREAS, Dealer Tire, LLC, a Delaware limited liability company, (the "Company"), entered into a Security Agreement, dated as of April 29, 2003 (as from time to time amended, modified or supplemented, the "Security Agreement") between the Company and National City Bank (the "Lender") pursuant to which the Company granted a security interest (the "Security Interest") in certain trademarks and trademark applications, including without limitation the trademarks set forth on the attached Schedule A (the "Trademarks"); and

WHEREAS, all of the secured obligations have been fully paid and satisfied and the Lender desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Lender hereby releases the Security Interest, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Security Agreement, (ii) sells, assigns, conveys, transfers and sets over to the Company any right, title or interest that the Lender may have acquired and re-vests in the Company the full unencumbered title to the Trademarks and the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Security Agreement.
