TRADEMARK RELEASE, effective as of this 29th day of September 2009, given by JEFFERIES FINANCE LLC, as Second Lien Collateral Agent (the "Agent") with principal offices at 520 Madison Avenue, New York, New York 10022, to NORTH AMERICAN AIRLINES, INC. NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quitclaims and relinquishes unto the Grantor the security interest in the Marks set forth on Schedule A attached hereto granted to the Agent by the Grantor pursuant to the Collateral Agreement, which security interest was duly recorded on August 14, 2009, at Reel 004044, Frame 0474 in the United States Patent and Trademark Office.
