- 13. If the Seller fails to accept this agreement by 6:00 o'clock PM October 10th 2009, then the Buyer may revoke this agreement, in writing.
- 14. The closing shall take place immediately following signing of this agreement and funds will be wired into Seller account within 72 hours.
- 15. The Seller warrants that it has a clear and marketable title to the FranchisesForSale.com domain and "FranchisesForSale.com" trademark being sold.
- 16. The Seller warrants there are no claims against the "FranchisesForSale.com" trademark or disputes
- 17. Seller will provide all clear UCC filing from State.
- 18. Buyer will provide special advertising contract to Seller for five years agreement at a rate of \$3,200 annually with no addition cost to advertise for up to 5 Franchise Brands listed on the www.FranchisesForSale.com and www.FranchiseCompany.com websites
