ASSIGNMENT OF SECURITY INTEREST

THIS ASSIGNMENT OF SECURITY INTEREST is made and entered into this 4th day of September, 2009, by NATIONAL CITY BANK in favor of FIRST NIAGARA FUNDING, INC.

WHEREAS, NATIONAL CITY BANK and FIRST NIAGARA BANK have entered into a Purchase and Assumption Agreement whereby FIRST NIAGARA BANK has acquired certain assets of NATIONAL CITY BANK, including security interests;


