**SECOND AMENDMENT TO ARTICLES OF INCORPORATION
OF
THE AUTOM CHURCH SUPPLY COMPANY**

Pursuant to the provisions of A.R.S. Sections 10-1001, et seq., the undersigned Corporation adopts the following amendment to its Articles of Incorporation:

1. The name of the Corporation is The Autom Church Supply Company (the "Corporation").
2. Pursuant to A.R.S. Section 10-1003, on August 31, 2009, the Board of Directors and the Shareholders of the Corporation adopted the following amendment to its Articles of Incorporation:
 - a. Article 1 is hereby amended by deleting such Article in its entirety and replacing the deleted Article 1 with the following:
 1. Name. The name of the Corporation is Christian Brands, Inc.
 - b. Except as expressly amended herein, all other provisions of the Articles of Incorporation of this Corporation shall remain unchanged and in full force and effect as originally filed with the Arizona Corporation Commission.
3. The number of shares of the \$1.00 par value common stock ("Common Stock") of the Corporation issued and outstanding at the time of such adoption and entitled to vote thereon was Three Hundred Fifty (350) shares of Common Stock.
4. Three Hundred Fifty (350) shares of Common Stock voted for the amendment, and zero (0) shares of Common Stock voted against the amendment.
5. The number of shares of Common Stock cast for the amendment was sufficient for approval by that voting group.


