## TRADEMARK ASSIGNMENT

This Trademark Assignment ("Trademark Assignment") is made and entered into as of the date last set forth below (the "Effective Date") between ALAVEN CONSUMER HEALTHCARE, INC., a Delaware corporation ("Assignee"), and ALAVEN PHARMACEUTICALS LLC, a Delaware limited liability company ("Assignor").

### RECITALS

NOW, THEREFORE, effective as of the Effective Date, in exchange for good and valuable consideration including compensation paid to Assignor, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers unto said Assignee, its successors and assigns, the entire right, title and interest in and to said Trademarks, said United States trademark registrations, any and all trademark registrations which may be granted in any U.S. territorial possessions and any and all trademark registrations which may be granted for said trademarks in any and all foreign countries, and in any and all renewals thereof, including the right to file foreign trademark applications directly in the name of Assignee and to claim priority rights deriving from said United States trademarks to which said foreign applications are entitled by virtue of international convention, treaty or otherwise, including for all said Trademarks, without limitation, the goodwill symbolized by and associated with said Trademarks, said Trademarks, goodwill and all trademark registrations on said Trademarks to be held and enjoyed by Assignee and its successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment, transfer and sale not been made.

This Assignment may be executed in multiple counterparts, each document of which shall be deemed an original, but all of which shall constitute one and the same instrument.
